



ABOUT GSA 8(A) STARS II

8(a) STARS II is a multiple-award, indefinite-delivery/indefinite quantity (IDIQ) contract which allows us to provide simple to complex technology services to federal agencies. Using 8(a) STARS II will enable you to access 8(a) firms through an established contract vehicle instead of traditional, open-market methods - saving time and taxpayer money.

CONTRACT SCOPE

The scope of the 8(a) STARS GWAC is centered on four functional areas (Fas) derived from the North American Industrial Classification System (NAICS). The contract offers simple to complex IT service solutions such as:

- IT Help-Desk Support
- Information Assurance
- Cyber Security
- Virtualization
- IPv6
- Web 2.0 & more

The 8(a) STARS GWAC is structured with two tiers known as constellations. The constellation design is new to the 8(a) STARS II GWAC, and offers additional features and benefits. Constellation I include prime contractors who are technically proficient and offer competitive pricing.

ORDERING

Prior to issuing orders under 8(a) STARS II, federal contracting officers are required to receive training on the use of the 8(a) STARS II contract and be granted a written delegations of procurement authority from the GSA Small Business GWAC Center. Training is offered at no cost via:

- A self-paced, online course
- Onsite training conferences and events
- Web or video conference
- Conference calls

The **ordering period** for the 8(a) STARS II GWAC ends August 30, 2021, and orders awarded on or after July 1, 2020 under 8(a) STARS II must be complete by June 30, 2022.
